MAP OF BOUNDARIES OF ANGLETON DRAINAGE DISTRICT



NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Angleton Drainage District and may be subject to district taxes or assessments.
